Fire Station Named After First Black Mayor of Huntington

The West Virginia Human Rights Commission (HRC) would like to congratulate their 2023 Civil Rights Award recipient Joseph Williams Jr. on having a fire station named in his honor. Local and federal officials along with members from HRC attended the opening ceremony of the Mayor Joseph L. Williams Fire Station on November 9, 2023, located on the corner of 9th Avenue and 20th Street in Huntington, celebrating the \$5.3 million investment in the city of Huntington.

Considered a champion fighter in the Fairfield community and a dedicated official in the city of Huntington, Joseph was the elected first black mayor of Huntington in 1984. He is also credited with the founding of the Ebony Golf Classic, which attracted golfers from around the United States and Canada. He was also chairman of First Sentry Bank and was president and CEO of Consolidated Bank and Trust in Richmond, VA, from which merged Premier Financial Bancorp Inc. He founded many organizations in the Fairfield area that have benefited stakeholders in his area. He is a member of the Marshall Board of Governors, where he was just elected into the Black Alumni Hall of Fame and served on the US Small Business National Advisory Council during President Bill Clinton's administration. Even though he has obtained much political and financial success, he has never left his community.



Fair Housing Leadership: Building an Equitable Future
