ORDER

On the 7th day of May, 1986, the Commission reviewed the Findings of Fact and Conclusions of Law of Hearing Examiner Theodore R. Dues, Jr. After consideration of the aforementioned, the Commission does hereby adopt the Findings of Fact and Conclusions of Law as its own, with the exceptions and amendments set forth below.

The Commission hereby amends the Examiner's Recommended Findings by deleting therefrom Conclusions of Law Nos. 3 and 4 and substuting therefor the following Conclusions of Law:

- "3. The Complainant established a prima facie case of age discrimination in employment by proving that she was a member of a protected class (over age 40); that she was qualified to perform the duties of her job as a waitress; and that her hours were reduced and her employment was later terminated while younger employees with similar qualifications were retained without reductions in work hours."
- "4. The respondent articulated legitimate non-discriminatory reasons for complainant's work reduction and

termination in that there was a reduction in business leading to her reduction in hours and that she was terminated because her performance was not of the quality of the employees that were retained."

- "5. Complainant failed to establish by means of any credible evidence that the reasons articulated by the respondent set forth above were pre-textual. All credible evidence shows that there was a reduction in business and that complainant's work, while generally satisfactory, was not of the quality of the employees who were retained considering the fact that Mr. Laury was attempting to change the nature of the business to a higher quality establishment upon his purchase of it (Tr. 106)."
- "6. Accordingly complainant has failed to meet her burden to establish a violation of the West Virginia Human Rights Act."

It is hereby ORDERED that the Hearing Examiner's Findings of Fact and Conclusions of Law be attached hereto and made a part of this Order, except as amended by this Order.

By this Order, a copy of which shall be sent by Certified Mail to the parties, the parties are hereby notified that THEY HAVE TEN DAYS TO REQUEST A RECONSIDERATION OF THIS ORDER AND THAT THEY HAVE THE RIGHT TO JUDICIAL REVIEW.

EXAMINER'S RECOMMENDED FINDINGS OF FACT AND CONCLUSIONS OF LAW

This case matured for public hearing on July 17, 1985. The hearing was held at the Conference Room of the Daniel Boone Building, 405 Capitol Street, Charleston, WV. The panel consisted of Theodore R. Dues, Jr., Hearing Examiner. The parties waived the presence of a Hearing Commissioner. The Complainant appeared in person and by her counsel, Roxanne Rogers. The Respondent appeared by its counsel, Cynthia L. Turco and by Otis Laury, its representative.

FINDINGS OF FACT

- 1. The Complainant, Betty Jo Kinder Rider, is a white female age 49.
- 2. The Complainant is experienced in performing the duties of a waitress.
- 3. The Complainant was hired by the Respondent as a waitress in 1978 as a waitress.
- 4. The Complainant's hours were reduced during the months of September 1978 to January 1979 as a result of a reduction in business.
 - 5. The Complainant was laid off in January 1979 due to

the reason that her performance was not of the quality of those employees that were retained.

CONCLUSIONS OF LAW

- 1. The West Virginia Human Rights Commission has jurisdiction over the subject matter and the parties in this matter.
- 2. As in all cases, the Complainant bears the burden of proving the allegations of her complaint that the Respondent discriminated against her in its decision to reduce her hours of work in the latter part of 1978 and in laying her off in January 1979.
- The Complainant failed to establish a prima facie case by failing to introduce evidence to establish that the reduction in her hours or the layoff were in any credible way connected to her age.
- 4. Accordingly, the Complainant has failed to establish a violation of the West Virginia Human Rights Act.

RELIEF
